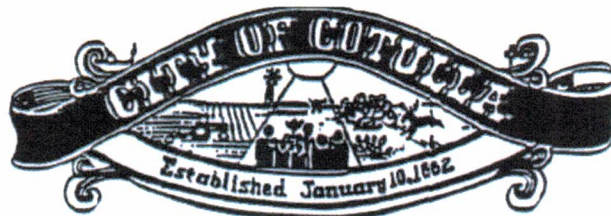

7. **Discussion and possible action on appointing an Alderman Place One for the unexpired term of office until the next regular election date.**


Motion to pull item #6 and item #7 was made by Councilman J. Garcia. The motion was seconded by Councilman T. Lopez, with all in favor.
